### Qualifications:

- Bachelor's Degree in computer science, information technology, or any IT- related course.
- 8 hours of relevant training/certifications in items related to the scope of work
- At least 2 years of relevant work experience in software development, programming, and database management systems
- With expertise in scripting and coding languages and standards

- Proficient in Oracle DB (at least 11G) database management systems

### Scope of Work:

Under the guidance and technical oversight of a PIDS Research Fellow who serves as Project Director, two (2) contract of service (COS) workers are expected to work with the Project Team to assist in or undertake the following tasks/activities:

1. Provide programming and technical assistance to the PhilHealth Universal Health Care Surge Team (UHCST) in the continuous development and enhancement of existing DRG IT systems for PhilHealth, including but not limited to:
  - a. Data exchange platform and application programming interface (API) from PhilHealth to PIDS for the sharing of claims data, statements of accounts, and other routinely collected administrative data, as needed
  - b. Z-benefit packages IT system and database
  - c. Other PhilHealth IT systems applicable to DRGs, global budget, and co-payment/cost-sharing
  - d. The systems will be developed using either React or PHP within the Laravel framework, with Oracle DB serving as the database management system

2. In line with #1, the COS Worker shall deliver comprehensive documentation for each IT system developed, including the following wherever applicable:

- a. The complete source code with code comments and annotations, build and deployment instructions, and API documentation
- b. Comprehensive data dictionaries, database schema, data validation rules, and sample datasets
- c. User manuals for end-users to operate the software
- d. Technical manuals for system administrators and developers

The COS Worker shall assist PhilHealth in integrating the new IT systems #1 in existing benefit payment IT systems, also developing reporting mechanisms and front-end interfaces for IT systems end-users.

3. Prepare for, attend, and present at internal meetings, or client meetings with PhilHealth, DOH, and other stakeholders to explain and answer queries on the system, as necessary.

4. Perform such other professional, highly technical, and confidential duties and responsibilities as the Research Fellow may assign from time to time.
